If you have any issue accessing the documents, promptly return this email stating such and I'll make an appointment to hand-deliver the documents to you personally.

P.S As for the condition of the buildings at 38 County Road 1, I just want to mention that it's in the condition that it is because of the serious oppression campaign that I've endured in my community for years. Members of the community colluded against me to conceal dirty little secrets and they've nearly destroyed my whole life in the process. I've put an incredible amount of blood, sweat, tears, money and time into that place and the community just continues to rally against me. Instead of helping me, my community hinders me. Time and time again, I've appealed for help from my community and over and over again I just get alienated and treated like scum on the bottom of the PEC community shoe.

After learning about the history of Freemasons and United Empire Loyalists, it's no wonder why, especially when I blew the whistle on the sick network sexually abusing children in local foster care homes. My efforts eventually brought down the whole PEC CAS, saw foster parents convicted and the exposure of William Sweet, the former Executive Director. This is why that house looks the way it does. This is how the community treats genuine child welfare workers.

PEC staff and police have harassed me for years with frivolous complaints and whatnot but it's being taken to the next level now. Access to my own house, with no notice, is forbidden, allegedly for sewage and structural issues.

Well, anyone with a brain knew that I was living off-grid for the last several years and that there has been no use of the tradition septic system. I live a clean, responsible lifestyle on that property where everything is safely and responsibly composted. Shutting my house down for a system that hasn't been employed in years is arbitrary, differential treatment.

As for the roof, I've been trying to get that repaired for a while now. It was about to happen this past spring but before I could get started the unsafe order was issued. My progress is stalled in the absence of any responsible adult or PEC employee having the nerve or audacity to deal with me in an upfront and upright manner. As for any other structural issues, they were being upgraded bit by bit as I could afford it and as my health permitted but instead of helping, PEC staff showed up to hinder and here I am now.

As for the roof, I guess I'll put the money elsewhere. The house can rot and fall down for all I care at this point. It represents so much of my life and the corruption in PEC that I should turn it into a tourist attraction and erect a plaque that explains the horrible oppression that one experiences if considered an outsider by the community that they were born and raised in.

As it stands, I'll be living on that property. I will live in the out building. I will do what it takes to maintain that property and to defend what's mine.

Behind that house is a beautiful backyard. I don't see much of the house from there. The main people who see my house are the neighbours and community members, many of whom who joined in my oppression, and I don't care what they see anymore. They can look at it every day and remind themselves about what they've done to me and how they destroyed my property for their sick associations.

I mean, the community is full of charity and good deed doers but somehow all of the benevolence of PEC overlooks me and leaves me to survive in the worst of conditions. Churches were once happy to help me with charity but once I blew that whistle they just alienate me and turn me out with a sick sort of glee.

The people of PEC can watch the house cave. I don't care. I know that PEC is all about their aesthetics so whenever they're ready to put out an offer to help me instead of to hinder me, perhaps some progress will be made and they can have the pretty look of conformity back. Lord knows it's probably driving them all so crazy to look at the ugliness of that property. That ugliness, however, is a reflection of the true heart and soul of PEC and PEC can deal with it. I'm done jumping hoops.

If my community doesn't want to come help me then they can watch it rot for all I care. The rotting will tell an important story over time. I don't care anymore. It's just a material building. I've lost so much of my own life at this point, it's just time now to put it all on the line. It's all or nothing for me.

My community has done all but kill me off. A house is neither here nor there to me now, although I do not consent to its removal, alteration or demolition by outside forces such as the PEC building department or even the higher governments if it end up evolving into a bigger matter. I'll live on that property one way or another no matter what it takes. I don't care. This needs to be understood... MY COMMUNITY HAS DRIVEN ME PAST THE POINT OF CARING ABOUT MATERIAL ITEMS. THEY HAVE PUSHED ME TO THE POINT THAT I ONLY CARE ABOUT TRUTH AND MY OWN LIBERTY. I'M DONE PLAYING GOVERNMENT GAMES.

How is having Freemasons in the government not a conflict of interest? How can I ever succeed in a community that is loyal to the foreign CROWN of the TEMPLE? How can there ever be justice when every lawyer on the land known as Canada belongs to the TEMPLE BAR? The corruption is just too much. I can't fight it. I can only go around it. I'm doing that with EQUITY and enforcing my right to life, liberty and security of person.

Damn the lies. Damn the liars. I DON'T CARE ANYMORE!

The PEC government, PEC service providers and the 'circle of friends' in the community has stepped on me and held me down for far too long. I'm rising up and there's not a damn thing anyone can do about it.

I've watched the self-proclaimed elite people of PEC destroy the once well-knitted community and drive away the 'undesirables'. I've watched the police and the CAS destroy too many good people and families. It's sick. That story must be told!

All government and its agents must stand down and back off. A person can only take so much. I've followed all of the avenues to justice and I've learned that justice is simply and illusion in the myth of 'Canada'. How could it not be when the courts and governments were 'built' by Templars, Freemasons, Jesuits and Lucifer loving heathens?

I'm done with the illusion and I'm done playing the game. Until the County gets real and treats me like a human freaking being, I'm done. Done, done, done!
