## **CANADA IN PERIL**

## THE MASONIC FRATERNITY: AN ETHICAL DILEMMA AND PUBLIC CONFLICT OF INTEREST

- Non-political

If those assertions were accurate and true, this document would not exist.

Clandestine fraternities, orders and societies have been at work in all levels of government in Canada, acting as a shadow government.

In the context of government corruption, there are other orders beyond those of Freemasonry at play. The Masonic fraternity, however, is one of the largest and most influential fraternities in Canada, acting as a shadow government, at this time.

The government, judiciary, police, the public service sector and the general civil society of Canada have all been infiltrated with members of clandestine orders, many of whom are Freemasons.

A myriad of problems develop, as we see with our current state of affairs, when elected officials and regulated professionals put themselves in obligation to clandestine third-parties such as the Masonic fraternity.

The people of Canada must urgently scrutinize and respond to the influence that Freemasonry is having on elected officials and regulated professions in Canada.

With that being said, there are many fraternities, orders and societies that add to the problem of double, clandestine agents within the government and public service sector. Some orders are affiliated with Freemasonry while others are in staunch opposition to it. This is where the people of Canada must understand that many of these groups are medieval war machines. Religious schisms and varying political alliances have made many of these orders difficult to understand and to subsequently trace the history of.

Many orders claim to have some connection to the Knights Templars. Others, like Ignita Veritas, claim to be sovereign and running parallel to the United Nation, with Inns of Court, and professional Bar. The order claims to owe its succession to papal secrecy while further claiming to have affiliations with Freemasonry.

Below, the reader will find evidence of various criminal elements of Freemasonry. From this author's perspective, the Masonic fraternity is no better and no worse than any other clandestine fraternity that influences society in the absence of transparency, accountability or informed consent. <u>It's this author's opinion that ALL clandestine agents</u> become accountable to the people of Canada - NOW!

## SHADOW GOVERNMENT - THE CLANDESTINE MASONIC FRATERNITY IN CANADA - CRIME AND INFLUENCE - THE EVIDENCE

SECRET OATHS AND UNLAWFUL SOCIETIES WERE ONCE CONSIDERED TO BE A THREAT TO THE SECURITY OF A NATION. EVENTUALLY, THROUGH SUBVERSION, THE LAWS AND PUBLIC VIGILANCE BECAME RELAXED AND FREEMASONS WERE ABLE TO CONTINUE INFILTRATING WORLD GOVERNMENTS IN THE ABSENCE OF PUBLIC SCRUTINY AND SUBSEQUENT OVERSIGHT AND ACCOUNTABILITY.

## UNLAWFUL ASSOCIATIONS

"Section 98 (s. 98) of the Criminal Code of Canada was a law enacted after the Winnipeg general strike of 1919 banning "unlawful associations." It was used in the 1930s against the Communist Party of Canada.

After the Winnipeg general strike of 1919, Arthur Meighen, Minister of Justice in Robert Borden's government, introduced an amendment to the Criminal Code. The legislation was tabled in the House of Commons on June 27, 1919, where it was passed with little to no debate. In the Senate, it only took two days to pass going on to receive royal assent on July 7, 1919. Section 98 read:

Any association...whose professed purpose...is to bring about any governmental, industrial or economic change within Canada by use of force, violence or physical injury to person or property, or by threats of such injury, or which teaches, advocates, advises or defends the use of force, violence, terrorism, or physical injury to person or property...in order to accomplish such change, or for any other such purpose..., or which shall by any means prosecute or pursue such purpose...or shall so teach, advocate, advise or defend, shall be an unlawful association.

The law was extremely broad and carried a penalty of up to 20 years in prison. It was used throughout the 1920s and early half of the 1930s to harass Communists, other left parties and organizations, and labour unions generally. The most well-known use of Section 98 was in a crackdown designed to "strike a death blow at the Communist Party." The Royal Canadian Mounted Police and the Ontario Provincial Police rounded up eight leaders of the Communist Party on 11 August 1931, who were subsequently

convicted under the law and sentenced for up to five-year prison terms. In the years after the conviction, public opinion turned in favour of the Communists and against the law, which was opposed by liberals and moderate leftists as well as far-left organizations like the Canadian Labour Defence League, a Communist legal defence committee. As a result of public opposition, the Communists were released early from jail and the law was repealed in 1936 following the election of Mackenzie King in 1935.

Opposition to Section 98 was an important campaign for crystallizing an early civil rights movement within an otherwise fractured left wing in Canada. Although the law was repealed, it served as the model for the Defence of Canada Regulations under the War Measures Act to suppress aliens and dissenters during the Second World War and during the October Crisis of 1970."

#### ALLEGED MASONIC OATH;

I, , of my own free will and accord, in the presence of Almighty God, and this Worshipful Lodge, erected to Him and dedicated to the holy St. John, do hereby and hereon most solemnly and sincerely promise and swear, that I will hail, ever conceal, and never reveal any of the secrets, arts, parts, point or points, of the Master Mason's Degree, to any person or persons whomsoever, except that it be a true and lawful brother of this Degree, or in a regularly constituted Lodge of Master Masons, nor unto him, or them, until by strict trial, due examination, or lawful information, I shall have found him, or them, as lawfully entitled to the same as I am myself. I furthermore promise and swear, that I will stand to and abide by all laws, rules, and regulations of the Master Masons Degree, and of the Lodge of which I may hereafter become a member, as far as the same shall come to my knowledge; and that I will ever maintain and support the Constitution, laws, and edicts of the Grand Lodge under which the same shall be holden. Further, that I will acknowledge and obey all due signs and summons sent to me from a Master Masons' Lodge, or given me by a brother of that Degree, if within the length of my cable tow. Further, that I will always aid and assist all poor, distressed, worthy Master Masons, their widows and orphans, knowing them to be such, as far as their necessities may require, and my ability permit, without material injury to myself and family. Further, that I will keep a worthy brother Master Mason's secrets inviolable, when communicated to and received by me as such, murder and treason excepted. Further, that I will not aid, nor be present at, the initiation,

passing, or raising of a woman, an old man in his dotage, a young man in his nonage, an atheist, a madman, or fool, knowing them to be such. Further, that I will not sit in a Lodge of Clandestine-made Masons, nor converse on the subject of Masonry with a clandestine-made Mason, nor one who has been expelled or suspended from a Lodge, while under that sentence, knowing him or them to be such. Further, I will not cheat, wrong, nor defraud a Master Masons' Lodge, nor a brother of this Degree, knowingly, nor supplant him in any of his laudable undertakings, but will give him due and timely notice, that he may ward off all danger. Further, that I will not knowingly strike a brother Master Mason, or otherwise do him personal violence in anger, except in the necessary defense of my family or property. Further, that I will not have illegal carnal intercourse with a Master Mason's wife, his mother, sister, or daughter knowing them to be such, nor suffer the same to be done by others, if in my power to prevent. Further, that I will not give the Grand Masonic word, in any other manner or form than that in which I shall receive it, and then in a low breath. Further, that I will not give the Grand Hailing Sign of distress except in case of the most imminent danger, in a just and lawful Lodge, or for the benefit of instruction; and if ever I should see it given, or hear the words accompanying it, by a worthy brother in distress, I will fly to his relief, if there is a greater probability of saving his life than losing my own. All this I most solemnly, sincerely promise and swear, with a firm and steady resolution to perform the same, without any hesitation, myself, under no less penalty than that of having my body severed in two, my bowels taken from thence and burned to ashes, the ashes scattered before the four winds of heaven, that no more remembrance might be had of so vile and wicked a wretch as I would be, should I ever, knowingly, violate this my Master Mason's obligation. So help me God, and keep me steadfast in the due performance of the same.

#### STATEMENT OF JOHN QUINCY ADAMS;

Statement of John Quincey Adams, sixth president of the United States, on the Assassination of William Morgan by Freemasons:

"Freemasonry, corporate Freemasonry, is chargeable with the stealing of a free citizen, and the murder of a father and husband. The proof of this subject is perfectly conclusive and is to be found in the reports of the trials of the kidnappers of William Morgan, and in the official accounts given by different Special Attorneys.

It is responsible for having baffled inquiry, for having defeated investigation by the removal of witnesses and for having produced the acquittal of persons notoriously guilty.

It has been decided by Judge Marcy in New York and by two sets of triers at circuit court held by Judge Gardiner in the same state, and by a court in Rhode Island, that the obligations of Freemasons disqualified a man from being an impartial juror in a case where a brother mason was a party; and such undoubtedly is the law of the land.

The Grand Lodge of New York has given one hundred dollars incharity to one of the most guilty kidnappers of Morgan. The Grand Chapter of the same state has given one thousand dollars to aid and sustain other well-known kidnappers and to enable them to escape from justice, at a time when they had no money to bestow in charity to widows and orphans. This has recently been established in the trial of a libel suit brought by Jacob Gould, which was tried at Albany, New York.

But perhaps the most remarkable evidence of the binding force of masonic obligations and of the real power of the fraternity is afforded in the conduct of those who control the newspapers of the country.

When the English forger Stephenson was kidnapped in a distant state and brought forcibly to New York, the whole country rang with the alarm which was sounded by the newspapers and every patriot was called on to resent this Invasion of personal liberty.

But when a free citizen of America was dragged from his family, forcibly carried through the country and drowned in the deep waters of the Niagara, a death-like silence pervaded the newspapers; or if they spoke, it was to notice the outrage in terms of irony and as a trifling and unimportant affair.

The papers of every party teemed with the most gross misrepresentations; a simultaneous attack was made on all who are engaged in discovering the offenders; fabricated accounts of Morgan having been seen at different and distant places were incessantly circulated and every effort was made to delude the public and mislead inquiry.

How tremendously powerful must have been that organization, which could produce that shameful treachery of the press to its public duties.

These facts are as notorious as the sun at noon-day and stronger proof of their general truth cannot be adduced, than the single circumstance that to this day, thousands and millions of reading citizens of this country are ignorant of Morgan's abduction and murder and are totally uninformed of the abominations of Freemasonry."

Most Worshipful Grand Master of the Most Worshipful Grand Lodge of Texas, Right Worshipful Grand Officers, and Brethren:

I'm a Shriner in Texas. I have been a Shriner for many, many years.

I am also a Jester in the Royal Order of Jesters within the Shrine. I have not attended Blue Lodge in ages. I am going to leave my name anonymous for various reasons. I am married to a wonderful woman (the 2nd one in my life thanks to the Shriners) and I have children who have moved on to lives of their own. However, what I am about to portray to you could endanger my life and the life of my family.

I have told a few select brethren the story I am about to relay to you. I am not sure who they told, if they told anyone. More than likely, when you are done reading this email, you will surely be in disbelief of what has transpired in the past, what is transpiring

today, and what is planned for the future within the Shriners organization to the disgrace of Ancient Free and Accepted Freemasonry.

When I started Masonry prior to the mid 70's, it was the best experience of my life. The brotherhood that I found was beyond belief. The Blue Lodge was truly the pinnacle of my Masonic experience. I became a 32nd degree Scottish Rite Mason that same year, although I never really participated in the organization. I became a Shriner somewhere in that time period. This is where my story really begins...

While in the Shrine I was very active. Taking my family with me on the weekends to events was a very exciting time in my life, and the life of my family. I was approached in the Shrine and was told that I was a good Shriner and that I was invited to join a secret society within the Shrine--The Royal Order of Jesters. This "secret society" was started back in the late teens of the 20th century. The motto was "Mirth is King" and was devoted to not brooding over sorrows, but to forget them as far as possible. This meant home life as well.

My brothers, I am a sinner. I have sinned against my family. I have sinned against myself. I have sinned against God.

The Holy Bible, Master Mason Edition, 1 Corinthians 5:11:

"But now I have written unto you not to keep company, if any man that is called a brother be a fornicator, or covetous, or an idolater, or a railer, or a drunkard, or an extortionist; with such an one no not to eat."

During the initiation of new Jesters I was offered the opportunity by another fellow brother to sleep with a whore, even though I had a wife and kids waiting for me to come home. I was not strong at the time and I violated every oath I had ever taken with my wife. This did not stop at initiation. These were a constant occurrence at our Jester functions and they are a common occurrence today. The initiation practices have not changed as well. Prostitutes were offered/made available at our functions and often brothers would have sex in front of other brothers.

Oral sex competitions between brothers were considered "fun" activities to build a strong brotherhood bond between members of the Royal Order of Jesters. Potentates and Chaplains, Attorneys and Judges, Past Masters and brothers all participating or watching with open eyes, but closed minds. I often felt ashamed of what I was doing,

but the pleasure outweighed the guilt. I had fallen within a deep hole and my cable-tow had been severed.

Sex, illegal gambling and alcohol were and are the preferred order of business to ease the "pain" of brother Masons. Prostitutes are available at Jester functions for the brothers to have their way with.

There is also illegal gambling at our functions where Masonic brethren are playing high-stakes games with hard-earned cash. I have seen it all, brothers, and it is going on today, right under your noses, within your communities, and these men are calling themselves your Masonic brothers.

I am currently active in the Shriners and the Jesters. I am ashamed of what I have become and what the Shriners have become. I have seen threat after threat made against Masonic brothers who have not agreed or have spoken against the activities of our club. These activities are in every Royal Order of Jester's club in the USA, and beyond our borders. You would be surprised if you knew who was Jester from your local Blue Lodges--outstanding, moral men--at least by their outwardly appearance. Our Most Worshipful Grand Chaplain of the Most Worshipful Grand Lodge of Texas is a member of the Royal Order of Jesters, along with the Deputy Grand Master of the Most Worshipful Grand Lodge of Texas!!! I'm calling you out brothers. It is time for us to raise the bar of Masonry in Texas, even at the expense of our fraternity. Our Most Worshipful Grand Master Elmer Murphy of the Most Worshipful Grand Lodge of Texas always talks about the character of a Master Mason and now he has the opportunity to present his true Masonic character when dealing with this issue given how close he is in relation to current active members in the Royal Order of Jesters.

The Jesters pride themselves in having control of all leadership positions at all of the Shrine Temples in the US and Canada as well as the Imperial Shrine leadership. Also, they have risen through the ranks in every body of Masonry including the Scottish Rite, York Rite, Rosicrucian's, Red Cross of Constantine, Eastern Star and the Demolay organizations. There have been numerous past masters of the Grand Lodge of Texas who have been Jesters, including our most recent Grand Master Boyd Patterson, Reese Harrison Jr., and Michael Nanny. Find out who these other Masons are brothers within your local lodges and hold them accountable for their actions. I have invoked the cry of a Masonic brother in need of help!

I lost my first wife due to her finding out what went on at one of my outings. Don't let this happen to your Masonic brothers or your friends. I am not sure if anyone in the Blue

Lodge really knows this is going on, but to those of you receiving this email, you are now armed with the knowledge and it is the truth. I challenge you to prove me wrong.

I ask the Most Worshipful Grand Master Elmer Murphey of the Most Worshipful Grand Lodge of Texas to conduct a full Masonic investigation into these allegations. I ask you, my brothers, to do the same within your local Blue Lodges. I am guilty. Hold me accountable, hold your Masonic brothers accountable, and hold our Most Worshipful Grand Master accountable!!!

I charge myself and every member of the Royal Order of Jesters in the State of Texas under the Laws of the Grand Lodge of Texas, Article XIII, Section VI, Paragraph 5, "Behavior at Home and In Your Neighborhood":

"You are to act as becomes a moral and wise man; ...and by avoiding gluttoness or drunkenness, that your families be not neglected or injured, nor you disabled from working."

I also invoke the request to the Most Worshipful Grand Master under Title V, Discipline, Chapter 1

Article 498 (531) "Accused's Lodges to Be Notified--notification to lodges of members who are members of the Royal Order of Jesters."

Article 499 (532) "Neglect by Lodge of Duty to Disclipline-District Deputy Grand Masters should obtain list of Jesters in their jurisdictions."

Article 499a "Powers of the Grand Master- Set this investigation in motion and work to re-establish our Masonic beliefs of 'Making Good Men Better'."

Charges I believe should be filed against every member of the Royal Order of Jesters:

Article 506 "Certain Other Offenses":

2. "Actions which disgrace Masonry."

5. "To indulge in the intemperate use of intoxicating liquor, gambling or profane swearing."

8. "To willfully abandon his family."

#### 13. "To cohabit with lewd women."

I encourage blue lodges in other states to conduct investigations of their own into these allegations as well.

I ask the Most Worshipful Grand Master of the Most Worshipful Grand Lodge of Texas to suspend all Master Masons in the State of Texas who are members of the Royal Order of Jesters, which would cease their activities within the various Shrines across the state until a full investigation may be conducted.

This email is going out to every lodge in Texas that has a website, the Grand Lodge officers of every state, the York and Scottish Rites.

Please ask questions, talk about this in your Blue Lodge, and contact the Most Worshipful Grand Master Elmer Murphey and demand this be investigated by the Grand Lodge of Texas. This information will eventually go before the public eyes if it is not handled within our Masonic fraternity. Let every Master Mason who is in a position of leadership or anyone thinking of ascending to a position of authority be on notice that their activities in the Royal Order of Jesters and their adherence to the Masonic oaths and morality will be brought into the light.

Again I am pleading for an immediate statewide investigation and a purging of the Grand Lodge line, Scottish Rite, York Rite and the Shrine. I have collected 18 local chapter rosters as well as the national Kochina group rooster. I urge every Mason to forward this e-mail to as many brother Masons and Shriners as possible. ## **ORDER OF GARTER - CANADIAN JUDICIARY CORRUPTED**

"One of the most notable features of any British Columbia courtroom is the large coat of arms on the wall behind the judge's bench. Unlike courts in many other Canadian provinces, all of the courts in our province have traditionally displayed the Royal Arms of the United Kingdom, the official coat of arms of the British monarch. It features two mottoes - "Dieu et Mon Droit" and "**Honi Soit Qui Mal y Pense**"

Heraldry in BC has a long and interesting history, and the use of the Royal Arms of the United Kingdom in the courtrooms of British Columbia is not without controversy. While serving as District Registrar of the BC Supreme Court, Mr. Justice Blok wrote that the use of the Royal Arms, rather than the coats of arms of Canada or British Columbia, properly reflected the independence of the judiciary from the executive and legislative branches of government. As he put it, "Not only must the judiciary be separate, it must be seen to be separate."

Mr. C.S.T. Mackie responded with a call for change, and argued that the coat of arms displayed in British Columbia's courtrooms is a relic of colonial times. In Mr. Mackie's view, since the coat of arms displayed in a courtroom traditionally symbolizes the sovereign whose authority is exercised in that courtroom, courtrooms of the BC Provincial Court should display the BC Royal Arms, and courtrooms of the BC Supreme Court and Court of Appeal should display the Canadian Royal Arms.

The courts and BC government ministries responsible for court facilities have considered the arms displayed in court rooms many times and declined to change them. There are legal and historical arguments for maintaining the traditional coat of arms. There is also a practical reason for all B.C. courtrooms to use the same arms – in many areas of the province both trial courts use the same courtrooms when necessary to accommodate trials.

While people interested in heraldry continue to debate the issue, B.C.'s courts have maintained tradition, and the Royal Arms of the United Kingdom continue to hang in our courtrooms."

## THE STENCH OF CORRUPTION IN CANADA'S COURTS

"Canada, especially British Columbia, has a serious problem with Freemason judges who fix the outcome of cases to benefit fellow Freemasons at the expense of innocent persons.

The public and all investors in British Columbia have much to fear now that their two trial courts are controlled by Chief Judges who are members of a secret society where members take mutual oaths to protect one another and where the those same Chief Judges will not disclose their membership in a secret society with a reputation for criminal conspiracy

Readers should take note that, in Canada, unlike the United States and the United Kingdom, Freemason lodges are governed by the Unlawful Societies Act. and Freemasons in British Columbia are deemed felons due to non-compliance with the Act.

## EVA SYDEL SUPREME COURT CHALLENGE

"Procedure – Conspiracy – Whether Canadian judges have a duty to disclose their membership in or association with a secret society – Whether the Government of Canada and Government of British Columbia have a duty to answer Interrogatories concerning membership of government employees or officers in Freemasonry – Whether the refusal of a judge to disclose his or her membership in or association with Freemasonry raise a reasonable apprehension of bias – Whether the Income Tax Act (1985) is valid legislation if the Income Tax Act (1948) is determined to have been a nullity – Whether the Income Tax Act (1948) was properly enacted in accordance with the mandatory provisions of the British North America Act – Whether the executive branch of government has the right to infringe Charter rights and freedoms secured by international treaty through the use of the criminal law – Whether the Unlawful Oaths Act (1797) and the Unlawful Societies Act (1799) prohibit Freemasons from acting as judges in Canada – Whether the Court of Appeal for British Columbia correct in its interpretation of the ambit and application of the ruling on the Supreme Court of Canada in the case of Ward v. The City of Vancouver, [2010] 2 S.C.R. 28.

This leave application arises from a challenge to the jurisdiction of the B.C. Supreme Court to dismiss a civil claim brought as a result of alleged improprieties, Charter breaches and other alleged wrongdoing occasioned during the course of criminal prosecution brought against Ms. Sydel, the applicant, in B.C. Provincial Court pursuant to the Income Tax Act by agents of the Government of Canada. In this case, Ms. Sydel

claimed at the B.C. Supreme Court that the investigation leading up to her convictions and the proceedings before the Provincial Court were part of a conspiracy against her engaged in by employees of the Canada Revenue Agency, lawyers employed by the Federal Department of Justice, and the Provincial respondents."

Today we find members of the R.C.M.P. playing a prominent part in Freemasonry, in the Knights of Columbus, in the Oddfellows, the Elks, Rotary, Kiwanis, Kinsmen, Lions, Y.M.C.A. and various other great fraternal or community groups."

#### **MILITARY CORRUPTED - FREEMASONRY**

"Canada is known for its peace keeping efforts over the years, as well as its involvement in war when called upon. Freemasons are not known for their war exploits, but as citizens of a British colony and later, of Canada, their support of national priorities are very strong and freemasons have joined the colours. As peaceful as we are as Canadians and freemasons we sometimes have to make war for peace. To preserve our way of life.

April 9, 2017 is the centennial of the capture of Vimy Ridge on April 9, 1917 by the Canadian Expeditionary Force: the first major British victory in the First World War. Although the four-division Canadian Corps was then under the command of British cavalry officer, Lieutenant General Sir Julian Byng, the planning and training concepts were developed and implemented by Major General Arthur Currie (later Lieutenant General Sir Arthur Currie, commanding officer of CEF) and his staff. Canadian Freemasons were there: R.W.Bro. Arthur Currie (a member of Vancouver and Quadra Lodge No. 2 of Victoria, BC), Major Generals Richard Turner VC of the 2nd Division and David Watson of the 4th (both members of St. Andrews No. 6 of Quebec City) and Malcolm Smith Mercer (of River Park No. 356 and Victoria 474 of Toronto) to the youngest, Private Thomas Ricketts of the Royal Newfoundland Regiment who enlisted at the age of 15½ and was awarded the VC at the age of 17 (although he didn't join Freemasonry until afer the war). Maj-Gen Turner had been awarded the VC for his actions at Leliefontein, South Africa, on November 7, 1900.

Our history has seen many periods of fighting on the local level (the French and Indian Wars, migration of Loyalists during and after American Independence, War of 1812, Rebellions of 1837 and 1838) as well as internationally (Crimea, South Africa, World War I and II, Korea) and the many Peacekeeping efforts. Masons and non-masons were there.

Some examples of our Freemasons in war include:

- Masons of Brigadier-General James Wolfe's army at Quebec formed a Provincial Grand Lodge under England in November 1759. It would oversee an area from Quebec city to Detroit which had added 75,000 citizens to Britain's new colony some of which were freemasons. Sixty-three masonic lodges would be formed during its existence: twelve in the area of the future Ontario. Early Freemasons would be there to begin to open up the area for settlement.

more lodges were formed in new towns established by immigrants and settlers who came directly from Europe or as United Empire Loyalists travelling away from the new United States by the 1780s. At Newark, Upper Canada (today's Niagara-on-the-Lake), Freemason and Loyalist Colonel John Butler and those of his men who were Freemasons attended meetings of two Lodges in the 8th (Kings) Regiment at Niagara. Or New Oswegatchie Lodge which was originally at Ogdensburg, NY, removed to Elizabethtown and is an ancestor of today's Sussex No. 5 at Brockville. Colonel John Graves Simcoe, our first Lieutenant Governor of Upper Canada, was a Freemason and

one of the first stone buildings in Newark housed Simcoe's administrative offices on the ground floor and the Masonic Hall upstairs.

- the War of 1812 would have its share of Freemasons: Laura Secord, daughter of Thomas Ingersoll, married Sergeant James Secord. Both men were Freemasons and members of St. John's Lodge of Friendship at Niagara (now St. John's No. 2) and fought in defence of Upper Canada. Indian allies such as Joseph Brant, James Brant and John Norton were also Freemasons and attended Lodge with our Loyalist and immigrant brethren. In this War, as in others, documents attest to Freemasons on each side helping each other in the midst of battle.

- during the rebellions of Upper (1837) and Lower (1838) Canada: where two future senior Freemasons were Sir Allan Napier Macnab (later Grand Master of the Antient Grand Lodge of Canada, 1857-58) who had first fought in the War of 1812 as a teenager and later fought in several engagements with Upper Canada militia against rebels, and William Mercer Wilson (the first Grand Master of the Grand Lodge A.F. & A.M. of Canada, today's Grand Lodge) who commanded a troop of militia cavalry in the Simcoe area where they fought rebels. And Canadian Freemasons fought in the Northwest Territories during the Riel Rebellions. During the second Rebellion a supply depot had been established on the South Saskatchewan river by Major General Wimburn Lawrie. At the time he was still Grand Master of the Grand Lodge of Nova Scotia and convened "occasional lodges" for the benefit of the masonic military personnel passing through the area.

- during the Crimean War period (1853-56): where Lieutenant Alexander Roberts Dunn of York would become Canada's first recipient of the new Victoria Cross (VC) which he received from Queen Victoria for his actions in the Charge of the Light Brigade at Balaclava (October 25, 1854). While not a Freemason at the time, he was initiated two years later in his father's lodge (Ionic 25 of Toronto).

And Canadian Freemasons would serve in South Africa (Boer War 1899-1902), through two World Wars, Korea, and many peacekeeping actions.

Masonic lodges had existed in military units from 1752 until the end of the 19th century. Their need was gradually eliminated when our military brethren found it easier to attend local, stationary, lodges in cities, towns and villages. Our Grand Lodge only ever authorized two military lodges under its authority. The first, for the masons of the Royal Artillery Garrison at Quebec, was formed in 1864 and closed in 1880. The

second, Canada Lodge, was formed in 2010 for the Freemasons in Canada's military then serving in Afghanistan. It closed in 2014 when the last Canadians returned home.

Freemasons who served the colours are remembered in various ways. The Masonic Monument at Malden Park in Windsor pays tribute to the members of our fraternity who made the supreme sacrifice during times of war. It was visioned and built at the beginning of the 21st Century by the members and lodges of Erie and Windsor Districts and while its focus is local it recognizes the worldwide effort of all freemasons to preserve our way of life."

The Jesters were operating under the guise of a local fishing tour company called Wet-A-Line. The photos, as well as testimony of human trafficking, arose under a Defamation lawsuit in Texas that arose when a competing fishing-tour company discovered the operation."

#### SHRINERS - 'DISBANDED' - SEX ACTS - HUMAN RIGHTS - MISOGYNY

"A group of Shriners in Winnipeg has been disbanded following complaints about lewd sexual behavior at a fund-raising dinner last week.

Witnesses say the event featured nude lap dancers and sex acts.

More than 400 men attended the annual V.I.P Gentlemen's Dinner, organized by the 50-member motor patrol unit of the Winnipeg Khartum Shriners.

The unit was disbanded after an emergency meeting of Shriners executives on Monday night. They also decided all unit presidents and secretaries will have to attend sensitivity training.

"Damaging their position as role models"

On Tuesday, the Manitoba Human Rights Commission got involved, saying such events demean women.

Kenneth Filkow of the Human Rights Commission said, "We have a concern about the kind of behaviour that was reported, and I think to try and pass a message on to men that they are potentially damaging their position as role models."

"We're talking about a very small group of people who have spoiled the good things of a very large number," said Bill Kubik, potentate of the Khartum Shriners.

The timing of the scandal is particularly embarrassing for the Shriners, who are best known for their jewel-studded fez hats. It comes just one month before the group's major fundraiser the Shrine Circus comes to Winnipeg."

## SHRINER - CHILD PORNOGRAPHY

"A Suffield school employee and former leader of the Shriners in Springfield has been charged with child pornography possession, posing a child in the nude and additional charges.

Gardner Whitney, 61, of Westfield, Massachusetts, was charged with indecent assault and battery, four counts of possession of child pornography, three counts of posing a child in the nude, and three counts of secretly recording a nude person, according to the Hampden County District Attorney's office. He was arraigned on Wednesday.

According to WWLP, Whitney denied the charges.

The Suffield School Department issued a statement on Friday afternoon.

"I received notification on January 23, 2013, from the Suffield Police Department, that a non-certified employee of the Suffield Public Schools was arrested on January 22, 2013 by Massachusetts State Police for possession of child pornography on equipment unrelated to school," Karen Baldwin, Superintendent of Schools in Suffield, said in a statement. "In accordance with its standard procedures, the District immediately began to work collaboratively with the police to investigate this allegation. The District will review the police reports and any further proceedings in this action to determine what, if any, further action should be taken by the Suffield Public Schools. As this is an ongoing investigation at this point, it would not be appropriate to comment further. However, please be assured that, as always, the safety and welfare of all of our students is our first priority."

Whitney has been with Suffield schools since 2009 and works as a tutor. School officials said that he is always with a staff member when he is with students.

The Shriners also issued a statement.

"We are saddened and deeply disappointed by the allegations facing former Melha Shriner Potentate, Gardner Whitney. Our thoughts and prayers are with the alleged victims during this difficult time.We expect our members to be professional, moral and ethical in all of their interactions with children, colleagues and community members. We will not tolerate any conduct that is inappropriate and unbecoming of a Melha Shriner. We will take corrective action and all disciplinary measures under organization by-laws whenever there is evidence of any misconduct. We encourage members of the Melha Shriners and the community to support each other through this difficult time, and look to a more positive tomorrow.""

The Independent Order of Odd Fellows originally limited membership to white men only. Thus, the Rebekahs began as the female auxiliary of the IOOF,Initially, only relatives such as wives or daughters of IOOF members were allowed.

Currently, both IOOF and the Rebekahs allow both female and male members. Likewise, nowadays women need not be related to an Odd Fellow to be a member of the Rebekahs. As long as she meets the moral, ethical and age requirement for admission, any woman may join. In most jurisdictions, women aged 16 or 18 years old and above can join a Rebekah Lodge."

## "BLESSED BE THE TIE THAT BINDS": VOLUNTARY ASSOCIATIONS AND COMMUNITY IN PICTON, ONTARIO, 1870- 1914

"This thesis is an investigation of the associational movement of the late nineteenth-century, and the changes to national voluntary associations of that period in the context of small town Ontario. The town of Picton serves as a case study, and al1 of the men's and women's associations in that town are examined. The thesis argues that these national associations were fundamentally local organizations. Their development was conditioned by the connections, familiarity, and intimacies of small town life. This thesis begins by examining the change in fraternal orders, from a local emphasis on the creation of brotherhood, conviviality, and mutual aid to a centrally-directed emphasis on large-scale benevolence. This shiR in power and purpose was precipitated by difficulties in recruitment, discipline and finances encountered at the local level. Small-town familiarity, informality and the desire to maintain local social harmony inhibited efficient management of the lodge system and also worked against the strict operation of fraternal regulations at the local level. The resulting 'crisis' in fraternalism led the national fraternal orders to modify their public image and their organizational structures."

## FREEMASONIC AND ORANGE ORDER MEMBERSHIP IN RURAL ONTARIO

"This study tests observations regarding the dynamics of fraternal organizations in urban and semi-urban Ontario communities against those in a rural settlement. The study focuses on Freemasonic and Orange Lodges that operated in a southwestern Ontario town of less than 2,000 persons between the late 1860s and the early 1900s. Exceptional results indicate fraternal organizations operating in rural Ontario during the late nineteenth century may have had some unique characteristics. Further study could test the wider applicability of these results and serve to shed further light on the role of fraternal organizations in community- and identity-building in rural Ontario during this period."

## **EYE OF PROVIDENCE - FREEMASONRY**

"Today, the Eye of Providence is often associated with Freemasonry, first appearing as part of the standard Freemason iconography in 1797 with the publication of Thomas Smith Webb's The Freemason's Monitor.

In this use, the Eye, representing the all-seeing eye of God, serves as a reminder that humanity's thoughts and deeds are always observed by God—who is referred to in Masonry as the Great Architect of the Universe. Typically, the Masonic Eye of Providence has a semicircular glory below it, and is sometimes enclosed by a triangle.

Popular among conspiracy theorists is the claim that the Eye of Providence shown atop an unfinished pyramid on the Great Seal of the United States indicates the influence of Freemasonry in the founding of the United States. However, common Masonic use of the Eye dates to 14 years after the creation of the Great Seal. Furthermore, the only Mason among the members of the various design committees for the Great Seal was Benjamin Franklin, whose ideas for the seal were not adopted. Likewise, various Masonic organizations have explicitly denied any connection to the creation of the Seal."

## IN EMINENTI APOSTOLATUS

"Freemasonry had developed in England in the seventeenth century, but after 1715 had split into Jacobite and Hanoverian lodges. The lodge in Rome was Jacobite (pro Stuart) and mainly Catholic, but admitted Protestants, while that in Florence was Protestant Hanoverian but also admitted Catholics and atheists who supported the Whig position. As Clement was from Florence, he did not view a prominent Protestant fraternity in his hometown favorably.

James Francis Edward Stuart was living as James III of England in Rome where he conducted a Jacobean court in exile. In 1737 he learned that Hanoverian Freemasons had recruited so many French Catholics that they had taken control of the Grande Loge de France from the Jacobites. He asked Clement XII to issue a papal bull condemning Hanoverian Freemasonry in the Catholic countries of Europe.

At the same time, Cardinal André-Hercule de Fleury was chief minister of Louis XV of France. Fleury was focused on maintaining peace with Britain. Jacobite sympathizers in France had formed a secret lodge of Freemasons; their attempts to influence Fleury to support the Stuart faction led instead to raids on their premises, and Fleury urged Pope Clement XII to issue a bull that forbade all Roman Catholics to become Freemasons under threat of excommunication."

## FREEMASONS - CHURCH OF ENGLAND (ANGLICAN)

"The issue of Freemasonry was considered by the General Synod of the Church of England in July 1987 in a debate on a Report Freemasonry and Christianity: Are they compatible? [available in hard copy from Church House Publishing]. The Synod's primary theological objection centred upon Freemasonry's use of the word "Jahbulon" [the name used for the Supreme Being in Masonic rituals, and an amalgamation of Semitic, Hebrew, and Egyptian titles for God]. The Report identified:

"a number of important issues on which, in the view of the Working Group, the General Synod will have to reflect as it considers 'the compatibility or otherwise of Freemasonry with Christianity'. The reflections of the Working Group itself reveal understandable differences of opinion between those who are Freemasons and those who are not. Whilst the former fully agree that there are clear difficulties to be faced by Christians who are Freemasons, the latter are of the mind that the Report points to a number of very fundamental reasons to question the compatibility of Freemasonry and Christianity."

General Synod passed the motion: "That this Synod endorses the Report of the Working Part [GS 784A], including its final paragraph, and commends it for discussion by the Church" by a majority of 394 votes to 52. However, the CofE web page on Freemasonry admits: "there have been no formal developments at national level since the 1987 debate".

Against this background, there has been an on-going involvement between Freemasonry and the Church of England in three areas: services and other activities

with cathedrals; donations; and membership of senior clergy. With regard to the former, these range from annual carol services to other non-liturgical events: in 2012, 800 Hertfordshire freemasons and members of the Rose Croix and Societas Rosicruciana attended St Albans Cathedral for a service of thanksgiving and the rededication of a pulpit, a gift from English Freemasons in 1883; on 21 September 2013 Canterbury Cathedral marked the bicentenary of Royal Arch Masonry.

The recent event at Canterbury was linked to a £300,000 donation from local masonic groups, the invitation to which stated:

"Freemasonry has been pleased to support Canterbury Cathedral for many years, helping to fund essential repairs to the building, and the training of a number of apprentice stonemasons. To mark this three hundred year celebration, a major donation of £300,000 has been made jointly by the Freemasons of Sussex, Surrey and Kent, to support the restoration of the Cathedral's North West Transept. Three hundred thousand, to mark three hundred years."

In the past, Church of England clergymen who have been masons include: the former Archbishop of Canterbury Geoffrey Fisher, who headed the Church of England from 1945 to 1961 and who held the senior post of Grand Chaplain for the United Grand Lodge of England; Robert Milburn, the former Dean of Worcester, also held this masonic office. John Habgood, former Archbishop of York, told General Synod that he believed Freemasonry was a "fairly harmless eccentricity" and later expressed the view that he did not see any conflict in being a Mason and a Christian".

More recently, the appointment of the Revd Jonathan Baker as Bishop of Ebbsfleet raised the issue again in view of his active involvement and as an assistant Grand Chaplain, a one-year appointment. Fr Baker is reported as stating that he did not consider Freemasonry incompatible with his Christian faith, but "because of the particular charism of episcopal ministry and the burden that ministry bears, I am resigning my membership of freemasonry"."

## **ELITISM - FREEMASONRY**

"A Grand Master is a title of honour as well as an office in Freemasonry, given to a freemason elected to oversee a Masonic jurisdiction, derived from the office of Grand Masters in chivalric orders. He presides over a Grand Lodge and has certain rights in the constituent Lodges that form his jurisdiction. In most, but not all cases, the Grand

Master is styled "Most Worshipful Grand Master."One example of a differing title exists in the Grand Lodge of Pennsylvania, where the Grand Master is titled "Right Worshipful". Under the Grand Lodge of Scotland, the role is titled "Grand Master Mason".

"In the United Grand Lodge of England, if the Grand Master is traditionally a **Prince of the Blood Royal** (ie: a member of the Royal Family), he may appoint a 'Pro Grand Master' ('Pro' is from the Latin for 'for') to be "his principal adviser, and to act for him on those occasions when, due to royal engagements, he is unable to be present". The Pro Grand Master is distinct from the Deputy Grand Master."

There are two distinct traditions in connection with the office of Grand Master. Generally speaking, the European practice is for the same Grand Master to be re-elected for several consecutive years, maybe even several decades, whilst in other countries, a Grand Master serves a set term of only one to three years and then retires.

In several European countries, the position of Grand Master has often been held by members of royal families or the high nobility. In some Protestant northern European countries, the position was held by the King for a long time. In England and Wales, the current Grand Master is Prince Edward, Duke of Kent, who was elected in 1967 and has been re-elected each year since."

"Since the office was established in 1789, 45 persons have served as president of the United States. Of these, 14 (around 31%) are known to have been Freemasons, beginning with the nation's first president, George Washington, and most recently the 38th president, Gerald R. Ford."

In addition to the individuals listed above, Lyndon B. Johnson was initiated into the first degree of Freemasonry – "Entered Apprentice", October 30, 1937, in Johnson City Lodge No. 561, at Johnson City, Texas, but did not advance any further and did not become a full member of his lodge, Ronald Reagan was made an honorary Freemason,

and as a youth, Bill Clinton was a member of the Order of DeMolay. Also, there is speculation suggesting that Thomas Jefferson was a Freemason; however, there is no record of him being initiated into any lodge, nor are there any references to Masonic membership in his personal papers."

## WEISHAUPT - ILLUMINATI

"Beginning with a narrow circle of disciples carefully selected from among his own students, Weishaupt gradually extended his recruitment efforts from Ingolstadt to Eichstätt, Freising, Munich, and elsewhere, with special attention being given to the enlistment of young men of wealth, rank, and social importance. From 1778 onward Weishaupt's illuminati began to make contact with various Masonic lodges, where, under the impulse of Adolf Franz Friedrich, Freiherr von Knigge, one of their chief converts, they often managed to gain a commanding position, It was to Knigge that the

society was indebted for the extremely elaborate constitution (never, however, actually realized) as well as its internal communication system. Each member of the order had given him a special name, generally classical, by which he alone was addressed in official writing (Weishaupt was referred to as Spartacus while Knigge was Philo). All internal correspondence was conducted in cipher, and to increase the mystification, towns and provinces were invested with new and altogether arbitrary designations."

After the suppression of Weishaupt's order, the title illuminati was given to the French Martinists, founded in 1754 by Martinez Pasqualis and propagated by Louis-Claude de Saint-Martin. By 1790 Martinism had been spread to Russia by Johann Georg Schwarz and Nikolay Novikov. Both strains of "illuminated" Martinism included elements of Kabbalism and Christian mysticism, imbibing ideas from Jakob Böhme and Emanuel Swedenborg."
