



RE: BRENDA EVERALL: IMMEDIATE ACCOUNTABILITY REQUIRED
APRIL 13, 2023
BAY OF QUINTE, ONTARIO

Dear service provider:

I own a home/property in Picton, Ontario. I paid my parents for the property/home years ago.

The problem is that I chose to advocate for children and families who were being terrorized by the seriously twisted child protection system in Ontario and the resulting oppression campaign that I endured caused so many problems in my personal life. So, while I technically and lawfully own my property, I don't, yet, legally own it.

At any rate, my aunt, who was acting as the power of attorney for my grandparents, along with a cohort of service providers, facilitated the death of my grandfather. Subsequently, my aunt abused my grandmother's rights, moved her into a retirement facility and sold off my grandmother's home, which was supplying water and driveway access to the family property that I bought from my parents. My father was supposed to inherit my grandparent's home but my aunt had other plans.

The issues that my aunt generated are still seriously adversely affecting me and other members of my family to this day. I tried to hold her and her supporters/enablers accountable but the corruption in Canada is so over the top that accountability would never come. Beyond that, the harassment that I've received from my municipal government has caused me sincere, serious grief.

Then, beyond that, the legal profession is so thoroughly corrupt, I can't get a legal professional to assist me with my legal matters. I've gone too far down the rabbit hole for their liking, apparently. There's only one lawyer that I've ever been able to trust out of

all of the lawyers that I've ever met in my life. Isn't that sad and shameful? When a person is on the 'wrong side of the system', lawyers tend to do their part in protecting the system over dissident whistle-blowers like me and, in doing so, they tend to make an unrecognizable mess of a person's affairs and then there's no recourse for the person that gets shut down by the lawyer's adverse actions because the Law Societies and social justice tribunals are so thoroughly corrupted. .

After years of trying to make it on my property the oppression campaign that I was enduring finally became too much and I moved to Belleville, in crisis, with my now adult son in November 2019. My son has been enduring serious systematic oppression in his own right but that's another story for another day.

My son and I are both experiencing serious medical tyranny. It's a very long story but we've both been abandoned by our family physicians while dealing with serious medical issues. I have a condition known as Morgellons Disease but, because the medical industry is so corrupt, it's taken years for the truth about this condition to be acknowledged by health professionals. Until this point in time, the condition was known as 'delusional parasitosis' but now, all of a sudden, the symptoms are slowly being referred to as 'long covid'.

Subsequently, I have another condition known as Hereditary Angioedema that, all too often, generates life threatening issues for me and for my adult children who inherited the condition from me.

I need my current service providers to assist me in securing healthcare services that actually acknowledge the complexities of angioedema as well as the condition that's becoming known as 'long covid' whereby my condition can finally be fairly evaluated and subsequently treated.

I wasn't always the 'dissident' that my community tends to view me as today. I was once employed at St. Andrew's Church in Picton and was a part of the good led circle of friends at one point myself.

My health began to significantly decline in the mid 2000's and I resigned from my duties at the church just before Reverend Lynne Donovan became the new minister. Shortly after Lynne's arrival, the so-called inclusive gang at St. Andrew's began setting up the Reaching for Rainbows program, a non-inclusive program for girls only, in partnership with the CAS. Lynne once told me that the Reaching for Rainbows program is how we practice social justice in Picton.

I was trying to expose that local youth were being assaulted in local foster care homes and that the CAS was abusing the rights of marginalized parents and their children. The so-called social justice oriented minister did not appreciate my advocacy efforts, to say the least. Lynne and my aunt would eventually host an intervention for me where they threatened to make false allegations against me to the CAS if I didn't stop advocating against the CAS. At the time, my aunt was also a foster parent herself.

Lynne Donovan would eventually kick me out of a public worship service, subsequently make false allegations against me while working with others within the Presbyterian Church in Canada to set me up for false charges. Eventually my kids and I were completely alienated from the St. Andrew's community even though we had St. Andrew's was the church that all three of had been baptized as infants and it was the only church community that we had ever known.

Because Lynne, my aunt and others from within the 'circle of friends' in Prince Edward County have so ferociously assassinated my character, others in the community treat me with utter disdain. As a result, it's been exceptionally difficult for me to get fair service from service providers due to the residual effects of the ongoing smear campaign that's been generated by this 'circle of friends'.

I constantly get the severe short end of the stick when it comes to having my car fixed, getting wood deliveries, receiving healthcare and social services, or just something as simple as getting a fair shake at the food bank. I'm constantly being attacked, in some way, by this network of people in Prince Edward County and the surrounding area. The cruel contention that this network doles out to those who don't fit into their elite club is offensively alienating and not conducive, in any way, to actual community inclusiveness.

Some of my oppressors include police officers and first responders. At this point, I verily believe that I would be left to die or that my house would burn down before the first responders showed up to a call concerning me or my property. It truly is that oppressive for me and mine in PEC. My kids have already endured an extremely traumatizing break-in where a fire was intentionally set while they were sleeping and, in my opinion, the community couldn't have cared less. The offender got his slap on the wrist and everyone went about their business like nothing ever happened, minimizing the situation and the effects that it had on my kids in doing so.

The circle of friends at St. Andrew's is part of a larger network of White Anglo Saxon Protestants (WASP) including United Empire Loyalists, Freemasons, Rotarians and others. People from within this circle of friends are often found running community programs like the food bank and other community outreach and charity programs, fair

administration, celebratory events, etc. These are the people that tend to write influential articles in local newspapers and gate-keep in the social media community groups. The Chamber of Commerce appears to be a popular forum for this group to circulate in as well..

It's surreal how the WASPs protect and enable one another. It would seem that prominent developers can wash their hands of manslaughter and the intentional violation of environmental laws while being one of the biggest slumlords in all of Prince Edward County. The so-called elite can, seemingly, traffic and abuse children and do whatever else they wish to do while the PEC OPP keeps guard and acts as personal bodyguards for them..

The circle of friends appears to be such a wonderful, helpful, and inclusive community. The problem is, however, if and when an individual doesn't follow the unwritten rules of the 'circle' or actually attempts to hold anyone within the 'circle' accountable for whatever various immoral or criminal acts, that particular individual will find themselves severely scorned and promptly ejected from the 'circle', and effectively socially alienated.

Once a person offends the WASP hive they're no longer welcome in or around the hive. The WASP's begin to refer to the outsider as 'dangerous' and 'threatening' and they relentlessly sting as a hive when the outsider attempts to interact within or around *their* 'community'..

I can assure the reader that I'm certainly not the only person in the community to have been 'disabled' by the collective sting of these WASPs. Many individuals and families have endured their wrath over the years!

This entitled tier of society takes care of them and theirs while destroying the once thriving and inclusive community of Prince Edward County, even if it has always been governed, for the most part, by so-called elite families

These elite families rarely, if ever, look outside of their own bubble to see who might be on the outside looking in. Once a person falls through the cracks, so to speak, people in PEC that were once family, friends or acquaintances will walk right over you, never offering to help to lift you back up.

Some may assume that I'm simply jealous because I was ousted from the 'circle of friends' and that, perhaps, I'm just seeking revenge against these 'poor people' because I'm so disgruntled. While it's true that I'm certainly disgruntled, to say the least, the truth

is that the circle of friends and the larger WASP network disgusts and subsequently offends me to my most inner core and I want absolutely no part of that sort of immoral community.

I do, however, truly miss being part of a community and I won't lie about that, but I won't be a part of something as toxic as the community that the 'circle of friends' currently purports. I sincerely look forward to rejoining the community once the corruption in PEC is exposed, subsequently acknowledged by the wider community and finally arrested, once and for all!

I won't 'whine' about the trauma that I've endured by the circle of friends in Prince Edward County but let it be known that this network has facilitated very serious harm in my life. I've been medicated by force, locked up in the psych ward, falsely arrested and incarcerated, beaten by police, and charged for serious crimes that I would successfully defend in the end. I've been robbed, assaulted and otherwise victimized, time after time, by various members of this network and accountability is never an option because this network of people stick together at all cost. It's almost as if these people are bound by oath to one another - like "a tie that binds".

At the end of the day, the claims that I was making about the a network of people concealing child abuse in Prince Edward County came to be realized whereby several foster care providers and the executive director of the CAS was criminally charged for the epic scandal. While the Executive Director ended up evading justice, in my most humble opinion, I think we all know what went down and I have the evidence to show that it was this network that I'm speaking of that enabled it all to go down as it did.

At any rate, after moving to Belleville, I ended up running into some family issues whereby the Highland Shores Children's Aid Society eventually became involved. Of course, Michael Evans from the HSCAS ended up causing detrimental, irreparable harm to me and other members of my family and never took one, single proactive step to help the children at the center of the investigation. As always, the CAS came into our life, turned it upside down and then ran away like scared, unaccountable chickens!

I filed an application with the Ontario Human Rights Tribunal in response to the extremely pathetic treatment that I received from Michael Evans/HSCAS. My HRTTO application somehow triggered an old case to resurface and now the matters are so extremely convoluted and insanely confusing. Instead of being responsible and accountable, the HRTTO is facilitating corruption, refusing to follow its own rules. The matter has become so upside down and, at this point, literally criminal.

Now, because of the dysfunction in my life, my parents refuse to speak to me. Now, I have to take legal action against them to get the property transferred into my name. The only problem with that is that I've been far too incapacitated and overwhelmed with the crazy, neverending corruption that I'm constantly subjected to. It's so difficult to relay just how difficult it is to live life when being targeted for oppression. One could say that I have ongoing-traumatic disorder because the trauma NEVER stops!

Not long after the HSCAS messed my life up, AGAIN, the Prince Edward County Building Department condemned my house. I wrote to the Mayor/Council, the Building Department and the Integrity Commissioner trying to deal with the matters but none of those parties, other than the Integrity Commission who informed me that he's powerless to investigate municipal staff, has responded to correspondence.

It's that crazy here in Canada - if and when a person finally gets in a position to hold their government accountable, their government just stops replying and sits there, hiding in the dark, hoping no one else notices.

I've informed the Integrity Commissioner of Canada, the Crown Attorney, the RCMP, the OPP and so many others that I'm being oppressed but no one cares. For real! Those that cause me harm expect me to keep rolling with the punches but I've been beat up and battered by the people who're supposed to be helping me for far too long now! It's intolerable!

My claims of oppression might sound incredible and unreal but I can assure the reader that my reality becomes evident if and when anyone takes the time and effort to review the actual evidence that I've made quite public and am happy to share upon request. I've been begging, literally, for service providers to respond to my dire situation for years but they just tell me how sorry they are that they can't do more for and they go off to hang out with my oppressors. It's such a surreal, constantly perplexing situation. I've been on this merry-go-round for years now and it's time for professional service to stop the ride and respond to the documented oppression that I'm experiencing, once and for all!

Most recently, ODSP decided to outright attack my liberty and personal security and that of my son. An ODSP manager came in and 'fixed' the problem but that manager was not interested, whatsoever, in holding the person who caused me so much grief accountable for their actions. From my perspective, it's just another cover up whereby the same old same old will continue to happen. The matter is currently before the Social Benefits Tribunal so let's just see what happens with that.

Still, I'm responsible for myself and my budgeting and these workers are allowed to arbitrarily upset my whole life and then walk away with no accountability. The fact is that harm was done, and it was intentional harm at that! I carefully prepared a budget that would carry me through the first quarter of 2023 and Sara Allport, my ODSP worker, comes along and obliterates the whole plan and subsequently causes me to incur unnecessary debt in return. I've had enough of being set up to look like a pathetic loser when I sacrifice like crazy to be financially responsible..

Since Sara Allport's attack on my personal finances I've not been able to keep up with the extraordinary cost of groceries and my health continues to decline under the stress and lack of nutrients that, in no way, is any fault of my own! If a service provider can't help me, the least they can do is not to harm me but, unfortunately, that's not often the case in my experience.

Beyond responding to the oppression in my life, I want and need appropriate assistance with officially lifting my organization off the ground. While I've been reduced to poverty and am a current ODSP recipient, I continue to volunteer in my community when I can. I've been working through my organization called Holistic International. I would appreciate any and all support available to assist in allowing this organization to thrive in the best interest of the underbelly of society that the mainstream system refuses to acknowledge much less provide effective responsive services to.

I've served this traumatized, paralyzed underbelly of society for many years now and, from my perspective, it's beyond time that I was properly funded! I'm providing far more of a service to the vulnerable people of society than the mainstream service providers are and my work needs to be recognized and properly funded, somehow, in return. I feel like a sitting duck, so to speak, on ODSP and I require and request the assistance required to help me to become fully autonomous and independent of the ODSP.

Nevertheless, it wasn't long after the matters with ODSP were being resolved, CRA started doing their thing and now my finances are being adversely impacted by that agency. Surely, their timing isn't coincidental! it's always one thing after another with these sorts of attacks. From my perspective, CRA is just the next one up in the who claims to be seeking 'accountability' from me while covering up all that's gone on in the past to get to the point that they're at now.

Matters tend to snowball so quickly when a person is dealing with corruption that it's hard for the person to relate the events that occurred in a linear, cohesive manner. In this way, the government continues its neverending assault in some way, shape or form

while the targeted person's life falls apart. It's disgusting and inexcusable and I've so seriously had more than enough of it!

What I'm relaying herein doesn't ever begin to speak to the magnitude of corruption that I've had to deal with in Canada as a child and family welfare advocate but it's a decent start, I suppose. I know that I'm coming off as angry and annoyed and that's because I am! From my perspective, after all I've endured, the so-called elite of Prince Edward County are fortunate that I'm balanced, loving and forgiving. It took many years for me to understand that the people who rally against me are rallying against the truth and that, in that way, these people are stuck in their own hell. While I can sympathize with that notion and subsequently find forgiveness in my heart for people who cause me harm, I still require accountability for them, naturally.

At the end of the day, I'm just so sick and tired. literally, of all of the unnecessary suffering in this world while the entitled families of our communities continue to step on others so they can rise up at the cost of those 'beneath' them.


At any rate, once I start speaking to the corruption that I've experienced, the subsequent suffering that I've witnessed and the resulting trauma that me, mine, and so many others have been forced to endure at the hands of this sick government in Canada, I tend to go on forever. Therefore, I'll just wrap it up here because I'm sure the reader is getting the picture.

For me, the nonsense that I'm speaking to must end here. It's time for elected officials, public servants and regulated professionals to do the right thing(s). Or not. Either way, I won't be silent or so easily pushed around from this point on. I've done my homework and I understand how this tyrannical corruption is operating in Canada, for the most part at least. From my perspective, the more I share what I know with others as opposed to fighting the unseen, dark forces of 'government', the people will do their thing over time and the government will, eventually, fall by its very own doing.

Only then will people know what life and living is all about - actual peace, love, liberty and justice. In the meantime, I won't settle for anything less than the truth and I expect those who provide a service to me to do so with an understanding of the trauma that I've experienced as a result of the corruption that I've experienced in Canada.

In closing, my life is an utter mess all the way around and has been for some time. As respectfully stated as possible, I demand and expect mandated service providers to help me effectively respond to that mess, doing whatever it takes to do so, once and for all!
