Ontario Provincial Police - Prince Edward County, Ontario

To whom it concerns:

Although I'm extremely wary of making contact with the PEC OPP due to experiences of severe oppression in the past, I feel that making a police report is a necessary step to take in the situation that I find myself in.

The property that I co-own and manage at 38 County Road 1 in Prince Edward County has been broken into and damage has been reported.

The property was maintained last year and then secured for the winter months. Visits were made over the winter months whereby everything on the property appeared to be safe and secure. With springtime arriving, I've been planning on getting over to the property for spring clean up and to get things ready for necessary renovations but in the interim, I received a report of the alleged breakin.

Further, I've received another report, not so long ago, indicating that a local business is trespassing on the property and causing serious, irreparable harm in doing so.

As such, I'm not sure how safe it is for me to attend the property for various reasons. I don't feel safe attending the property and I don't feel it appropriate to send someone else in my place, until I know that there is no danger in doing so. Potential trespassers pose a risk to safety and I'm requesting that the police investigate the matter to identify any potential threat before I attend the property to clean up the reported mess of broken glass and tend to any other matter that may pose a potential safety or municipal property standards issue.

Meanwhile, it's surely no secret that the municipal government is attempting to usurp the property. I wonder, therefore, if this is some sort of ploy to generate an appearance that I don't take care of the property which is most certainly not the case! At any rate, a human rights application has been filed against the municipality and legal action is pending against several individuals in a personal capacity. Some of the so-called officials in Prince Edward County have worked against me in bad faith, all of which I have strong, accumulated evidence of. In return, those individuals are personally liable for the role that they've played in oppressing me and mine.

As this particular matter continues to unfold, please understand that I've been assaulted and otherwise mistreated by police in the past and that, as such, I'm quite nervous about how I may be treated by police officers as this matter continues to unfold. Simply put, I'm far too sick and frail at this point to endure any form of police brutality. One of the last times that I was held in a cell at the PEC OPP detachment, for a matter that I was never convicted of, I was taken out of

the cell, unconscious, by paramedics. I was treated for an existing condition at the Picton hospital and then severely mistreated by officers once I was returned to the detachment.

I can't keep playing that game, so to speak. I'm simply too old and frail at this point. I have a physical condition that can generate potentially lethal swelling if I endure abrupt shock or intense physical or mental stress, especially when prolonged. To avoid these painful, life-threatening attacks I need to pre-plan nearly everything in my life so that I can maintain an appropriate environment conducive to my condition. I understand how frivolous the condition can appear to others but it's a very real problem for me in managing my day to day life and I need that fact to be respected by service providers.

With that said, I'm requesting the following simple disability accommodations:

1. That my fundamental human rights are consistently respected by OPP officers.
2. That officers acknowledge and respect that, due to my illness, I may not be immediately available to respond to them but that I will do so as soon as I possibly can.
3. An understanding that I communicate best, due to varying states of cognitive dysfunction, through text or email. Phone calls are, all too often, abrupt and I can't always retain the information that was verbally transmitted. I'll disclose, too, that in-person interactions between myself and police officers must be recorded. I'm not being frivolous or vexatious by operating in this manner. I've been forced into a lifestyle that requires me to record my daily interactions for my own protection otherwise I'd likely be in jail right now over false allegations that various so-called professionals continuously attempt to make against me. At any rate, I mean no personal offense to anyone, whatsoever, by recording my own personal affairs for my own protection and hope that officers can understand that.

I'm cautiously optimistic that I can have a somewhat positive or, at least, a neutral interaction with the OPP in this particular matter. Although I've had my issues with the police in the past, I'm certain that a mutual level of respect can be established if all parties are willing to start treating one another like human beings which I'm more than willing to facilitate on my part. I'm certainly not looking for further problems in my life, especially with the OPP. I'm simply trying to get to the bottom of matters that are adversely affecting me and mine at this time.

Thank you for understanding my difficult position. I look forward to hearing back from an officer in due course.
