Dear Valerie Labelle

On August 19, 2022 I received a response from the Deputy Commissioner, Denis Bilodeau, who directed me to contact you should I have any follow-up concerns.

Mr. Bilodeau provided telephone numbers for me to contact you at but, due to my cognitive disability, I'm requesting accommodation that circumvents telephone calls. As such, I'm requesting that matters hereon be handled through written correspondence wherever possible.

I had previously sent communications to the Office of the Integrity Commissioner with premature allegations of a clandestine government operating in Canada. I was wrong with my assertions about the powers that were behind the Crown but I knew that something wasn't right with how the Crown was operating here in Canada. As such, I kept researching and, now, I believe that I understand how the government of Canada has become so corrupt and subsequently out of control.

As such, I definitely have follow-up concerns about the way the government of Canada is operating in Canada. In fact, the more I learn about the actual structure of government in Canada my concern is rapidly escalating to alarm!

Let it be known hereafter that foreign powers appear to be operating behind the Crown and the Commonwealth in Canada. King Charles III merely represents, respectively, the Crown and the Commonwealth. King Charles III, himself, appears to be in obligation to members of the Accession Council whom the king subsequently swears a *sacred oath* to (or through). In this way it appears that the King obligates himself to clandestine powers and, in return, those who swear an oath to the King are, by default, obligating themselves to those very same foreign powers.

It further appears that particular agents of Parliament, such as the Office of the Integrity Commissioner, are potentially required to swear an oath to the Lord Chancellor of the United Kingdom or a similar clandestine entity. Subsequently, it appears that these so-called 'Agents of Parliament', take the Office of the Chief Electoral Officer for example, have direct ties to the Office of the Crown in Chancery where the 'Great Officers of State' operate a dual government system, headed by a Great Lord Chancellor and Secretary of State for Justice who just so happens to be the same individual, Alex Chalk.

After some research I can see that what's going on is all constitutionally sanctioned but it's all so extremely deceptive and incredibly unethical. The British Empire embedded itself into the British North America Act and that deception has been concealed from the people of Canada, at least for the most part, from my perspective.

Deception indicates that the government is not operating with clean hands and, as such, the people of Canada have all rights to cancel the contract, so to speak, concerning the constitution in Canada. Deception cancels contracts and the so-called government knows or ought to know this!

I'm of the opinion that the office of the Integrity Commissioner has attempted to conceal the actual nature of the government of Canada and how it operates by shutting me down in the way that I was by Denis Bilodeau on August 19, 2022.

As it stands now, according to at-hand evidence, the people of Canada and the nation itself are in potential peril due to what appears to be the clandestine occupation of Canada by foreign powers.

As far as I'm concerned, the outrageous deception that's occurring here in Canada effectively cancels the contract (constitution) established between the British Empire/Commonwealth and the People of Canada. **As such a new constitution for Canada must be urgently realized by the people of Canada!**

It's my opinion that the people of Canada are in unrealized peril because the Commonwealth of Nations, which is the former British Empire, is operating as a clandestine, parallel government to that of the Crown system in Canada.

I understand that personnel within the Office of the Integrity Commissioner may be silenced by oath and/or NDA while others may be fully complicit with the deception that's occurring here in Canada. Still, government personnel have, at the very least, a moral obligation to inform the people of Canada about the foreign powers that operate behind the Crown and the Commonwealth here in Canada.

At this point, I'm doubtful that that will happen but I remain somewhat hopeful that there may still be some 'agents of Canada' who govern themselves honestly and who might subsequently conjure enough integrity to do the right thing, so to speak.

At any rate, figuratively speaking, the jig is up. The former British Empire, now operating as the Commonwealth of Nations, is finally being seen for what it actually is. How personnel within the Office of the Integrity Commissioner govern themselves in response to this particular notice is on them!

From my perspective, it's a disgusting, unfathomably dishonest scam that's operating within the government of Canada; subjecting the people of Canada to genuine potential peril. It's far beyond time for the people of Canada to be informed about how the Privy Council in Canada is actually in service to foreign so-called elites!

On a final note, because this information is so highly sensitive and potentially dangerous for those who expose it, the Office of the Integrity Commissioner should provide protection to me as a whistle-blower. I'm a person who has just obviously marked herself for targeted oppression. I doubt any 'protection' can, or will, come from the Integrity Commissioner, however, because, as evidence indicates, the Office of the Integrity commissioner, itself, is part of the deceitful system that's operating, in service to foreign powers.
