

- 112. In response to the Crown Empire corrupting all that's good in Canada, I'll be executing several initiatives within my own community. One of these initiatives is to start a grassroots peer support clinic for general health, oral health and mental health supports. Although I am a certified medical office assistant, I'm certainly not a health expert nor am I licensed or otherwise regulated. What advice does Health Canada have for me to act in such a capacity?
- 113. Does Health Canada have any recommendations on how to safely and effectively baptize and to subsequently execute the rituals of the holy sacraments that are currently being obscured and otherwise controlled by religious authorities?
- 114. Does Health Canada have any information regarding the spiritual resurrection of the body and whether the resurrection occurs in an individual's lifetime (born again) or after their death?
- 115. Individuals have the literal ability to overcome the material world and, thereby, death itself. The kingdom of heaven is at hand and it is within each and every individual despite their nationality, race, age, gender or religion. Does Health Canada take a position on this particular statement?
- 116. I've attached, immediately below, a flowchart that I designed. I'm seeking review, should any employee of the Canadian healthcare portfolio be inclined to provide such. Many medical professionals are outright confused between terrain, germ and other theories and it's time that everyone in Canada who is interested in good health and well-being gets on the same page to restore good health in Canada. I'm using the flowchart as a starting point to understand the process of disease in the human body. I understand that my interpretations are likely to be heretical and against the grain of established medical opinions, however, science is always evolving and the allegedly scientific minds at Health Canada must evolve with it to have any continued validity as a public health authority in Canada, whatsoever!



I regret that my queries are so many, however, each question is valid and the answers are pertinent to the health and safety of myself, my loved ones and every other person in Canada. Although I do have several other questions, I'll leave it at that for now so that I'm not accused of being vexatious or frivolous in my attempts to get solid answers to serious questions. I'm being very genuine about these inquiries and, thus, I insist that I be treated as such by Canadian public health officials.

In my opinion, crimes against humanity and genocide are, without doubt, occurring, in real time, on Canadian soil, against the people of Canada. The people of Canada must resist the foreign Crown Empire regime if they are to preserve their own life, liberty and security.

The Military Provost Marshall, the Judge Advocate General, the Directorate of Special Examinations and Inquiries for the Department of National Defense, Canada's Integrity

The laws of equity must be learned and applied by the people of Canada. The Crown Empire has deceived the people of Canada and, thus, any and all contracts, including debt, made between the people of Canada and the Crown Empire are immediately nullified and forever void.

The problem that we have with the elected and appointed officials in Canada is elitism. Many of these so-called leaders come from 'nobility' and particular bloodlines.
