NOTICE OF ONGOING COLONIALISM IN CANADA AND SUBSEQUENT POTENTIAL PERSONAL LIABILITY

To understand what's being conveyed herein, a brief history lesson is potentially in order. While the actual history of Canada appears to be obscured, at least for the most part, to most of the people in Canada, it's seemingly taught at various so-called prestigious schools. As such, it's inappropriate for me to assume who may or may not be informed on the matter. I'll therefore present a basic overview of the obscured parts of the history that I'm referring to so that each of us can be on the same page as political matters in Canada progress.

The former British Empire wrote itself into the Canadian Constitution as the Executive Government. After WWII, the empire became known as the Commonwealth of Nations which solidified itself in the Canadian Constitution through the Statute of Westminster. Any constitutional loose ends were tied up by the Charter of Rights and Freedoms.

In this way, the Commonwealth of Nations appears to be constitutionally sanctioned to operate as the so-called executive government here in Canada despite the fact that association with the Commonwealth is purported to be on a voluntary basis.

All senior government, judicial and public service sector agents know or ought to know that there's a major difference between the Crown and the Commonwealth of Nations but, for whatever reason(s), as far as I can tell, Canada's so-called public officials make no attempt to make any clear distinction between the two for the people of Canada. In return, the people of Canada are unjustifiably misinformed about the actual nature and structure of the government system in Canada.

Based on available evidence, it appears that the people of Canada have been deceived and subsequently slowly conditioned to accept a constitutionally sanctioned foreign entity as their government. In return, from my perspective, the nation of Canada can't possibly be considered to be a free or self-determined nation! As a matter of fact, from my perspective, a national referendum and subsequent new Constitution for Canada is immediately required in the best interest of the people and nation of Canada.

Canada's so-called constitution guarantees a separation of legislative, executive and judicial powers. When the Supreme Court Justice is simultaneously the Administrator of Canada, the constitutional guarantee is obviously disregarded by the so-called powers that be. The Supreme Court Justice appears to have the so-called power to take charge of this nation, subsequently enabled to circumvent parliamentary control by issuing orders-in-council. The fusion of powers is deceptive and incredibly contrary to the ideals of a free people and nation. As such, I reiterate that a new constitution is urgently imperative in Canada at this time!

The so-called Crown and Commonwealth of Nations, respectively, trace back to the Crown Estate in the United Kingdom. The Crown Estate is not the Monarch, is not the U.K government, is not the Commonwealth of Nations but is, seemingly, the source of power that enables all of these exceptionally convoluted entities.

The so-called UK monarch swears allegiance to the so-called Accession Council that's directly connected to the Scottish Presbyterian Church. As such, any notion that there's been a separation between church and state is false! Further, the so-called king acts as so-called supreme governor of the Church of England and, subsequently, as the so-called defender of that faith while in simultaneous obligation to unseen overlords behind the Church of Scotland. In this way, fundamental religious repression appears to be driving the political repression that the people of Canada are increasingly subject to at this time.

The U.K Great Officers of State form one part of the extremely convoluted, dual system while the so-called parliamentary system forms the other. In this way, it's difficult for the average person to see the separation because many of those who facilitate the dual system play a dual role. For example, the UK Lord Chancellor is also the Minister of Justice.

After researching and coming to understand the actual nature and structure of government in Canada for myself, I can't possibly see how those working within the upper levels of the government remain naive to what's actually going on with the dual nature of the Canadian

government. I mean why would a country need a Prime Minister and a Governor General? In the same way, why would the provinces require a Premier and a Lieutenant Governor?

There's a dual set-up in the fundamental structure of the Canadian government and I don't see how you all aren't aware of that! Clandestine agents such as so-called ministers without portfolios, Agents of Parliament, High Commissioners, Great Officers of State and who knows what other deceptive agents are running rampant through the government systems of Canada, unbeknownst, for the most part, to the people of Canada.

The dual nature of the so-called Canadian government is reflected at the head of this letter where multiple addressed parties are clearly playing dual roles, at least, in their capacity as so-called public officials here in Canada. Some agents who aren't playing formal dual roles, such as the high commissioners, are, to say the least, constitutionally questionable characters with unacceptably obscured job descriptions!

The incredible, outrageous deception that I'm speaking to reveals itself here in Canada through the TREASURY BOARD SECRETARIAT, the only permanent committee of the Privy Council. In Canada, we find that the Chief Electoral Officer doubles as the Canadian Clerk of the Crown in Chancery. In the same way, the Attorney General also doubles as the Minister of Justice and so on. The so-called executive government literally hides in plain sight here in Canada.

The liberal government appears to be fundamentally aligned with the Commonwealth of Nations agenda while the current opposition leader, running under the re-designed Conservative Party (reform, alliance and PC), is an admitted monarchist in support of the so-called Crown system. The Cooperative Commonwealth Party, a name that surely speaks for itself, evidently evolved to become the modern-day NDP party. In this way, Canada's entire political system appears to be purely satirical!

The illusion that we have here in Canada is that parliament directs or otherwise keeps the government of Canada in check but when we take a closer look we find that so-called executive orders-IN-council trump parliamentary orders-OF-council! A legitimate government would have no need for such trickery nor would the following threat, found on the canada.ca website, be issued:

"In Canada's system of government, the power to govern is vested in the Crown but is entrusted to the government to exercise on behalf and in the interest of the people. The Crown reminds the government of the day that the source of the power to govern rests elsewhere and that it is only given to them for a limited duration."

Still, contractual deception does not and will not stand under law! As such, whatever contracts the deceptive so-called government is controlling Canada through are effectively null and void, now and forever! In this way, national debt belongs to Canada's oppressors and not to the nation or people of Canada!

Further, according to international law and subsequent international community standards, the nation and people of Canada have all rights to gain urgent independence from colonial oppressors with the subsequent right to self-determination; further yet, the right to actual decolonization! Although decolonization efforts intensified after WWII, rather than adhering to the international decolonization agenda, the British Empire, instead, deceptively engaged in neocolonial efforts, becoming the deceptive Commonwealth of Nations in doing so.

With exceptionally good reason, the international community considers any form of colonialism to be a crime against humanity! The effects of colonialism have left a deep, festering wound known as generational trauma that many individuals and families are currently attempting to heal here in Canada.

Meanwhile ongoing neo-colonial practices continue to add insult to that open, festering wound! Addictions, perpetual cycles of abuse, avoidable adverse mental health conditions, poor physical and oral health conditions, countless adverse issues surrounding deep-poverty and numerous other social-ills arise from unresolved generational trauma that is undeniably linked to the effects of colonialism!

Colonial policies have been traditionally enforced against the people of Canada by a prominent group known as the United Empire Loyalists (UEL). Historically, UEL's weren't interested in gaining freedom or independence from the Crown or British Empire, as evidenced by their refusal to stand with the patriots throughout history. UEL's were bestowed honorifics, land grants and special privileges that, in many cases, have been passed down by means of inheritance throughout the years. Many of the original settler families in Canada continue to enjoy those same honorifics, land grants and privileges to this day. In my local area, UEL's maintain, at least for the most part, the colonial status quo, making it extremely difficult, if not entirely impossible, to build an actual open and equitable community. I've learned in the most difficult ways possible that the network of UEL's collude to cause harm and devastation to those who *go against them*.

From my perspective, the neocolonialism that's occurring in the seemingly special area of Prince Edward County (PEC) is utterly mind-blowing. It appears to me that UEL's and other self-absorbed, so-called elites are attempting to subjugate unsuspecting, less fortunate residents in the area at this time whereby serious societal harm appears to be occurring. I, myself have been forced into a state of incapacitation due to the effects of a long-term oppression campaign in that very same UEL community. I'll address respective matters of personal oppression and neocolonialism under separate cover in due time.

It's my opinion, based on direct experience and subsequent research, that various projects, such as those proposed by an outfit known as BASE 31 in Prince Edward County, are potential forms of neocolonialism. So-called proud UEL's continue to collude, from my perspective, through such community forums as the Chamber of Commerce, Business Improvement Association and also through other so-called professional associations, philanthropic networks, esoteric circles, charities and so on.

It should be common knowledge by now that settlers began operating the so-called child protection industry back with the Home Children program back in the late 1800's. John A. Macdonald's cousins, the MacPherson's, among other settlers, were allegedly running that filthy operation whereby children were a literal commodity. That particular network, seemingly driven by UEL families operating under the guise of child welfare/protection agencies, is still systematically preying on children and their families for their own enrichment to this day.

The PECAS became defunct after merging into the Highland Shores CAS while several foster parents and the former PECAS executive director were eventually charged for their respective roles in the facilitation of sexual crimes against children. I did all that I personally could to hold key-players in that outrageous scandal accountable but the so-called system wouldn't have it and the truth of that whole matter is yet to be told.

Another example of neocolonialism in Prince Edward County is directly observed through the initiatives of the St. Andrew's Presbyterian Church in the town of Picton in PEC. Lynne Dovan, the minister, initiated a community program known as Reaching for Rainbows in association with the Children's Aid Society and other community partners. The program supports young females at so-called risk which, from my perspective, denies inclusion, opportunity and equity to male youth. The program is in partnership with the CAS and other community partners. Lynne Donovan once told me that Reaching for Rainbows is how we social justice is practised in that community.

At any rate, according to Lynne Donovan, her parents made a living from the residential school system while many years later, Lynne Donovan herself became heavily involved in so-called truth and reconciliation initiatives. It's in this way, in my opinion, that colonialism, through morphing pretences, is as alive now as it ever was.

The outdoor sign at the front of the St. Andrew's Presbyterian Church in Picton says that everyone's welcome to attend while a Human Rights Tribunal of Ontario decision against Deana (Lynne) Donovan, available on Canlii, certainly suggests otherwise! My experiences tell me that it's certainly not uncommon for so-called professionals in that community to pay lip service to the notions of equity, inclusiveness and social justice while, at the same time, stepping on the throats of those who may be a threat to their livelihoods.

At any rate, in the same year that so-called truth and reconciliation came about, the Canadian government was, at the same time, funding the John A. Macdonald project. A statue of Macdonald was eventually erected on the mainstreet of the town of Picton which led to controversy throughout Prince Edward County, the surrounding area and, in time, the nation itself. It certainly wasn't a surprise when the statue was finally removed but it's been interesting to note that the respective Tyendinaga and Prince Edward County governments, along with the Downie-Wenjack fund, seem to be controlling the reconciliation narrative in the Bay of Quinte region since that time.

Historical records indicate that some of the *natives* who settled in Canada from the United States were also United Empire Loyalists who were, in some cases, heavily involved with British government agents, even marrying some of them and subsequently bearing their children in some instances. As far as I can tell, particular political gatekeepers in the Bay of Quinte region continue to suppress the full, actual history of indigenous matters in Canada along with the genuine history of the Bay of Quinte and its inhabitants.

Let it be further known that it's the executive government, not parliament, that can send this nation to war and enter into international treaties in the absence of any parliamentary consent, whatsoever! So-called officials in Canada who aren't aware of that intolerable fact ought to be, given the level of trust and subsequent enumeration afforded to them by the people of Canada!

Because the so-called executive government of Canada consistently fails to engage in honestly candid dialogue concerning, among other issues, the Arctic Circle and the politics surrounding it, Canada and the people of Canada are being subject to needless international conflict and subsequent potential war.

If war is declared by or against this nation because of the corrupt executive government and so-called government officials do nothing to stop such after being informed herein about unauthorized agents generating a constitutional crisis in Canada, personal accountability will follow! The law will not shield bad-faith actors from civil liability, in any case, especially once the facts of this notice are accepted or otherwise acquiesced.

It's such an unconstitutional absurdity, from my perspective, that the so-called governor general of Canada is the Commander-in-Chief of the Canadian Armed Forces while simultaneously the prior of the clandestine military order of St. John for the whole of Canada while the Lieutenant Governors, also known as knights of justice, lead the order in their respective provinces. In this way the agenda of the governor general appears to be nefarious and completely out of touch with the ideals of a peaceful, so-called sovereign nation and people. In fact, especially at this point in time, the position of the governor general and the Office of the Secretary of the Governor General appear to be a direct threat to the political stability of Canada and thus by default, the life, liberty and security of the people of Canada.

The Usher of the Black Rod, associated with the clandestine so-called Most Noble Order of the Garter keeps the Canadian Senate in check, so to speak, allegedly arresting those who violate their oath or otherwise cause a *problem* during parliamentary procedures. The so-called king heads the Order of the Garter along with several other clandestine orders that are in no way accountable to the so-called common people of Canada or to the states of the so-called Commonwealth of Nations for that matter!

While it's rather impressive how these early modern, mediaeval, and in some cases ancient, orders, such as the Sovereign Military Order of Malta, evolved to become what they are today but, as far as I'm concerned, these clandestine orders need to be understood by the people of Canada for what they truly are and how they actually operate! Clandestine orders and

fraternities, as far as it seems to me, are not transparent or accountable to the people of Canada. The people of Canada, in my opinion, must force these various clandestine orders to disclose the nature and purpose of their operations or exile them from Canada, entirely!

It's such an incredibly deceptive set-up where so-called elites within the so-called government seem to think they're so clandestine and clever. Let's just see how proud various members of the deceptive so-called government are when the public learns how and why these so-called honours are achieved! From my perspective, the Canadian honours system (so-called system of nobility) needs to be urgently, thoroughly investigated and, in my opinion, subsequently dismantled by the people of Canada.

What's been done in the dark is coming to the light and all so-called government employees, agents and affiliates are urged to govern themselves accordingly at this time. When the people of Canada realize the actual nature and true design of the government in Canada, any bad-faith actor can and likely will be sued in a personal capacity!

Surely, morally guided individuals will be shocked and alarmed to learn that foreign powers are behind the Canadian constitution and that a dual, clandestine, system of government operates here in Canada. Nevertheless and at any rate, now that so-called government agents and associates have been made aware of that fact, all said persons have a personal choice to make. One can either remain loyal to the so-called king who, himself, is a vassal to unseen overlords or they can choose to stand in solidarity with the people and nation of Canada as the global agenda attempts to continue to unfold here in Canada.

Whatever choice individuals working within the so-called government, judiciary, armed forces and public service sector of Canada make for themselves, let it be known that the law does not shield actors of bad faith from personal liability in any way, shape or form! As we all ought to know and understand, the law protects professionals, public servants and so-called public officials who act in good faith. Once good faith is abandoned however, personal liability for any and all regulated professionals, public servants and so-called public officials activates at that time. No one is above the law!

In response to the ongoing tyranny in Canada, I've posted a good volume of information online about the nature and structure of the so-called government along with several of my associated grievances. If that website goes down at any point after I've sent out this notice, I will not rest until I find out how it went down and who was behind it. In a similar way, if sudden harm falls upon any of loved ones in retaliation to what I'm exposing I can assure the reader that whoever might be behind such a potential atrocity will be relentlessly pursued, exposed and subsequently brought to justice, one way or another!

Acts of reprisal are unlawful and won't, on any level, be tolerated. I'll defend, as vigorously as necessary, my inherent rights and dignity and that of my family, community and the nation itself! Those who work against me in any unlawful manner after receiving this notice will be exposed and held as lawfully accountable as need be!

The Mayor and Council members and various residents in Prince Edward County are especially urged to heed this warning, subsequently refraining from efforts to work against me or mine, in any way, any further. Far more than enough harm has already been caused to me and my family by key-players in that so-called proud UEL community and I won't tolerate a single further attack against me or mine before I begin to expose and subsequently sue the individuals and *circles of friends* in that community in a personal capacity as necessary while being as publicly visible and vocal in the community as I'm forced to become!

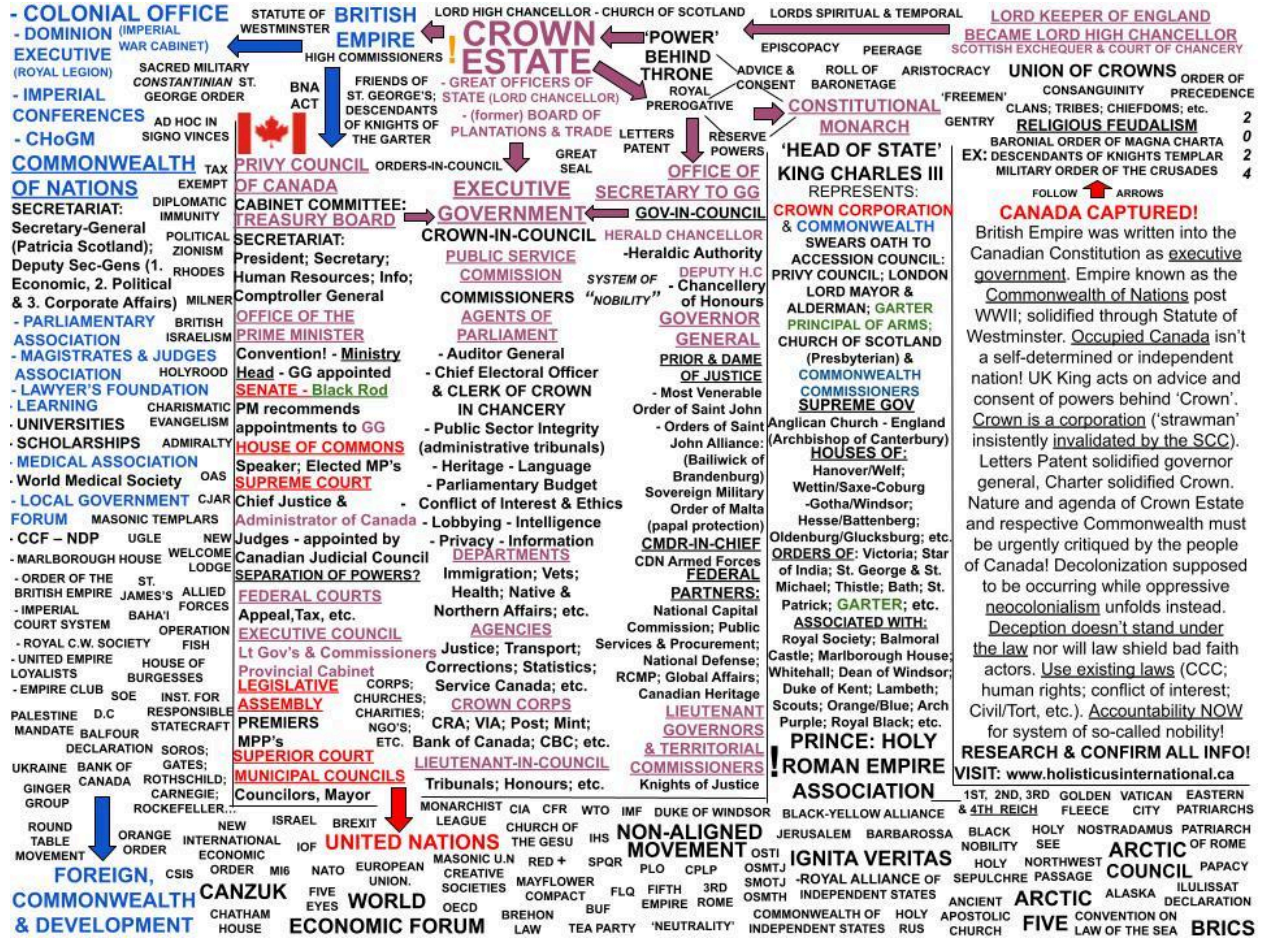
